Under the provisions of Council Procedure Rule 29 (a):

- If two candidates are nominated in respect of the election of a Committee Chairman or Vice-Chairman, the election shall be determined by way of a show of hands.
- If there are more than two candidates nominated, a show of hands will be taken for each candidate. If there is not a clear majority in favour of one person, then the name of the person with the least number of votes will be taken off the list and a new vote taken. The process will continue until there is a majority of votes for one person. However, if after this process, two candidates are still tied, the election shall be decided by the drawing of lots.

(e) Guildford Joint Committee Working Groups
