Amendment/Correction/Update List

20/P/01755 – (Page 43) - Merrow Centre for Remedial Education, 41 Downs Road, Guildford, GU1 2PZ

Amended plan (received 25 February 2021):

An amended site layout plan has been submitted which shows the 'as built' layout and corrects discrepancies on the originally submitted drawing. The amended plan shows the garden area to the rear of the flats 'as built' on site, extending to the rear boundary. The cycle store has been omitted as this has not been installed. However, the agent has confirmed that the applicant is intending to install secure cycle storage. An additional condition is therefore recommended to ensure details of the proposed cycle storage is submitted to the LPA for approval prior to installation.

Additional condition:

Within two months of the date of this decision, details of secure, covered parking facilities for bicylces within the development site shall be submitted to the Local Planning Authority to be agreed in writing by the LPA. These facilities shall be fully implemented and made available for use within 6 months of the date of this decision and shall thereafter be retained for such use at all times.

<u>Reason:</u> To ensure that satisfactory facilities for the parking of cycles are provided and to encourage travel by means other than private motor vehicles.
