Update to FOI Publication Scheme

Executive Summary

This proposal seeks the approval of an updated and revamped version of the Council's Freedom of Information Publication Scheme (originally drafted in 2009).

1. Purpose of Report

1.1 This report seeks to update the Council's Publication Scheme (originally drafted in 2009) to reflect the model template as recommended by the Information Commissioner's Office (ICO) and other changes as outlined below.

Approval for the revised version is sought from Executive.

2. Strategic Priorities

To make the public aware of what information is routinely available from the Council and how to access it.

3. Background

- 3.1 The Freedom of Information Act 2000 (FOIA) gives a general right of access to all types of recorded information held by public authorities. Section 19 of the Act requires every public authority to produce a publication scheme outlining the types of information which it makes available to the public as a matter of routine.
- 3.2 The Council's existing <u>publication scheme</u> requires updating to reflect organisational changes within the Council as well as legislative and regulatory developments including the implementation of the amended Data Protection Act 2018/UK GDPR and guidance produced by the ICO. The ICO's latest model publication scheme (2015) has since been adopted by many local authorities.
- 3.3 The types of information listed in the Scheme include:
 - Who we are Organisational information, locations and contacts, constitutional and legal governance
 - What we spend and how we spend it
 - Strategy and performance, plans, assessments, inspections and reviews
 - Policy proposals and decisions, decision making processes, internal criteria and procedures, consultations
 - Our policies and procedures
 - Information held in registers required by law and other lists and registers relating to the functions of the authority
 - Advice and guidance, booklets and leaflets, transactions and media releases
- 3.4 The new Scheme also provides links to frequently requested types of information on the Council's website including:
 - Planning applications/Planning committee meetings
 - Waste collections and recycling
 - Public Health Funerals
 - Business Rates

4. Consultations

4.1 Following consultations with the Council's Information Risk Group and approval from the Strategic Services Director, it was agreed to formalise the updated version.

5. Key Risks

5.1 The proposed updates will ensure compliance with the Freedom of Information Act and will assist the public in locating information which is made routinely available by the Council.

7. Legal Implications

7.1 Section 19 of the Freedom of Information Act 2000 imposes a duty on local authorities to adopt and maintain a publication scheme and to review it periodically.
