## Selection of Mayor and Deputy Mayor: 2025-26

### 1. Executive Summary

- 1.1 The Council is asked to consider nominations for the Mayoralty and Deputy Mayoralty of the Borough for the municipal year 2025-26.
- 1.2 The procedural changes adopted by the Council in April 2014 provide that the Council normally elects the Deputy Mayor appointed at the annual meeting of the Council as Mayor at the next succeeding annual meeting. The Council will therefore be requested to consider formally the nomination of the current Deputy Mayor, Councillor Howard Smith for the Mayoralty of the Borough for 2025-26.
- 1.3 Group leaders were asked to submit nominations for the Deputy Mayoralty for 2025-26 by no later than 22 November 2024. The only nomination received was:

Councillor Jane Tyson.

## **2. Recommendation to Council**

- 2.1 That the Deputy Mayor, Councillor Howard Smith be nominated for election as the Mayor of the Borough for the 2025-26 municipal year.
- 2.2 That Councillor Jane Tyson be nominated for appointment as Deputy Mayor of the Borough for the 2025-26 municipal year.

## **3. Reason for Recommendation**

- 3.1 To make early preparations for the selection of the Mayor and Deputy Mayor for the municipal year 2025-26.

- 5.1 To ask the Council to consider nominations for election of Mayor and appointment of Deputy Mayor for the municipal year 2025-26.

## **6. Strategic Priorities**

- 6.1 Ensuring that the process for selection of Mayor and Deputy Mayor is undertaken publicly is consistent with the Council's desire to be open and accountable to its residents.

## **7. Background**

### Selection of Mayor: 2025-26

- 7.1 The procedural changes adopted by the Council in 2014 in respect of the Mayoralty provide that the Council normally elects the Deputy Mayor appointed at the annual meeting of the Council as Mayor at the next succeeding annual meeting. The Council is therefore requested to consider formally the nomination of The Deputy Mayor, Councillor Howard Smith for the Mayoralty of the Borough for 2025-26.

## Selection of Deputy Mayor: 2025-26

- 7.2 Group leaders were asked to submit nominations in respect of the appointment of Deputy Mayor for 2025-26. One nomination was received:

Councillor Jane Tyson

- 7.3 The Council is asked to consider this matter to enable early preparations to be made for the formal election of the Mayor and appointment of Deputy Mayor for 2025-26 at the Council's annual meeting on 7 May 2025. This gives them time to make the necessary adjustments to their personal and professional lives in order to prepare for their forthcoming mayoral/deputy mayoral years and will provide plenty of time to enable appropriate training or refresher training to be given to the respective nominees.

## **8. Financial Implications**

- 8.1 The costs associated with the selection of a Mayor and Deputy Mayor will be met from within existing budgets.

## **9. Legal Implications**

- 9.1 The Council is required annually to elect a Mayor and appoint a Deputy Mayor in accordance with Sections 3 and 5 respectively of the Local Government Act 1972. The Local Government Act 2000 also provides that the Council's chairman or vice-chairman (the Mayor and Deputy Mayor) cannot serve on the Executive at the same time.
