

# **Guildford borough Local Plan Local Development Scheme March 2025**

## **1. Summary**

The Local Development Scheme (LDS) is the timetable and project plan for the new Guildford borough Local Plan. The LDS explains what Development Plan Documents we will be preparing and when, to plan for future development in the borough.

## **2. Background**

There are two different types of planning policy documents:

- Development Plan Documents (DPDs) - the Town and Country Planning (Local Planning) (England) Regulations 2012 refers to these as Local Plans. These are the main planning policy documents produced by the Council and form part of the statutory development plan for the area; and
- Supplementary Planning Documents (SPDs) – these are designed to expand on policies in DPDs or provide additional detail.

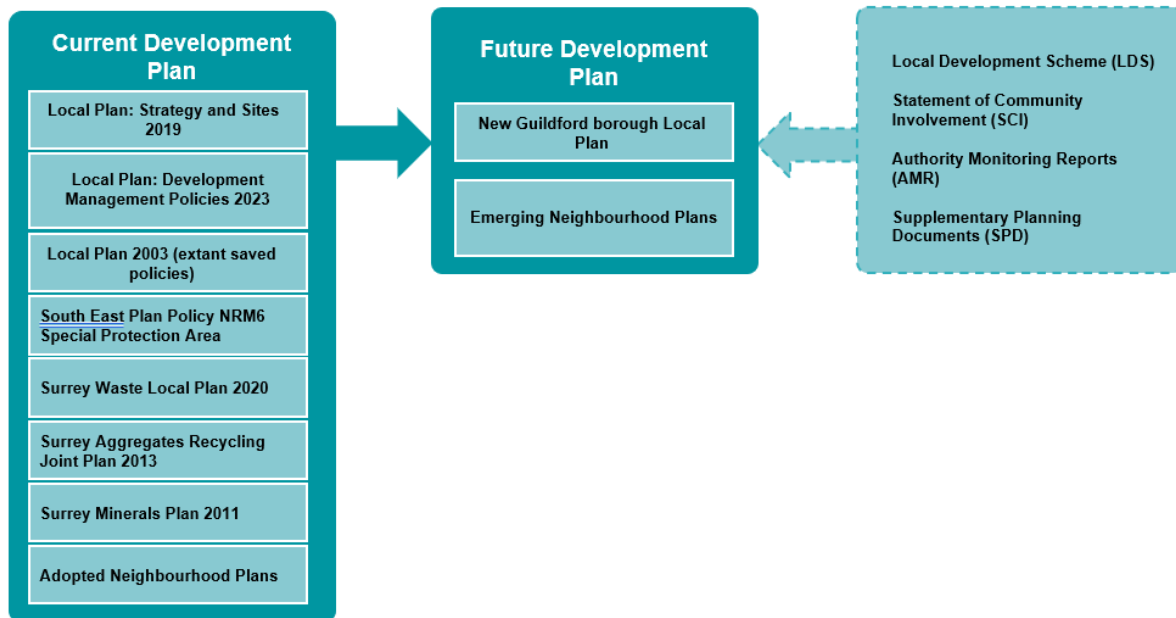
The Planning and Compulsory Purchase Act 2004 (as amended by the Localism Act 2011) requires councils to prepare and maintain an LDS setting out the DPDs that it intends to prepare, together with details and a timetable for their preparation. Following publication of the National Planning Policy Framework December 2024, Government requested that all local planning authorities prepare an updated LDS within 12 weeks of this, i.e. by no later than 6 March 2025. This LDS was adopted by Executive at its meeting on 27 February and came into effect on 7 March 2025.

The National Planning Practice Guidance (NPPG) states that the LDS must specify the documents which, when prepared, will comprise the Local Plan for the area. It must be made available publicly and kept up to date as it is important that local communities and interested parties can keep track of progress.

The current Local Plan for Guildford comprise of two parts; the Local Plan: Strategy and Sites 2019 (LPSS) and the Local Plan: Development Management Policies 2023 (LPDMP). In accordance with Regulation 10A of the Town and Country Planning (Local Planning) (England) Regulations 2012, the LPSS was reviewed in early 2024 (prior to its five year anniversary) and a decision<sup>1</sup> was made that it requires updating.

The Government is in the process of reforming the plan-making system as set out in the Levelling- up and Regeneration Act. The updated Local Plan is intended to be prepared as a ‘new style’ Local Plan with secondary legislation currently expected to be enacted in summer/autumn 2025. The Government also intends to consult on a set of National Development Management Policies (NDMP) in spring 2025. Any development management policies contained in the Local Plan update should not repeat these but can add further detail if justified by local circumstances. Any local development management policies must be consistent with the NDMP. This LDS will need to be updated once the secondary legislation is in place and the framework for preparing ‘new style’ local plans is known. This LDS has been prepared on the basis of the existing regulations (i.e. The Town and Country Planning (Local Planning) (England) Regulations 2012).

The composition of the existing and future development plan is illustrated in Figure 1 below.

### **3. The current planning policy position**

The development plan currently comprises the LPSS, the LPDMP and the residual policies from the Local Plan 2003. These are listed in Appendix 8 of the LPSS. All Local Plans are available here:

Policy NRM6 contained within the South East Plan 2009 that deals with the Thames Basin Heaths Special Protection Area is still relevant to the determination of planning applications.

The Government published the latest National Planning Policy Framework<sup>2</sup> (NPPF) in December 2024. Annex 1 of the NPPF states that the Council can continue to give weight to relevant policies in the adopted Local Plan according to the degree to which those policies are consistent with the NPPF (paragraph 232). Any new Local Plan being prepared must be consistent with national planning policy.

National Planning Practice Guidance<sup>3</sup> (NPPG) sets out how the NPPF should be implemented in planning decisions and development plans. It is an online resource that is capable of being updated regularly.

Planning for minerals and waste is the responsibility of Surrey County Council, which produces its own LDS for the future production and review of its Waste and Minerals Plans. We are a consultee during the preparation of these documents for Surrey County (including our area).

## **8. Policies Map**

A Policies Map geographically illustrates the land use designations, policies and site allocations of DPDs on an Ordnance Survey base map<sup>4</sup>.

The current Policies Map forms part of the adopted LPSS, LPDMP and the residual policies of the Local Plan 2003.

Any Local Plan must be accompanied by a Sustainability Appraisal (SA) (incorporating Strategic Environmental Assessment (SEA)). These will be published simultaneously as part of any consultation on the Local Plan.

There is also a legal requirement<sup>5</sup> to consider whether new planning policy documents are likely to have a significant effect on European sites of nature conservation importance, prior to the Plan being given effect. Habitats Regulations Assessment (HRA) will be produced for the Local Plan.

Equalities impact assessment (EqIA) screening (and if necessary, an EqIA) or similar will also be used to consider the potential differential effects of the Local Plan policies on sections of the community as we prepare these.

In preparing the Local Plan, we will comply with the requirements of the legal duty to co-operate, introduced by the Localism Act 2011. This requires local councils and other prescribed organisations to work together to cooperate on relevant strategic and cross boundary planning matters. Guildford Borough directly adjoins six other local planning areas – Woking, Elmbridge, Waverley, Mole Valley and Surrey Heath in Surrey and Rushmoor in Hampshire. Some strategic issues may require us to cooperate on an even wider basis and the organisations we need to work with will vary depending on the strategic issue. Our progress on complying with the duty to cooperate is reported through our Authority Monitoring Report ([www.guildford.gov.uk/localplan/monitoring](http://www.guildford.gov.uk/localplan/monitoring)).

Preparation of the Local Plan will also involve co-operation with Surrey and Hampshire County Councils, Highways England, the Environment Agency and a number of other prescribed bodies<sup>6</sup>.

## **9. Monitoring**

Progress against the LDS will be reviewed and reported in the Authority Monitoring Report. In doing so we will consider what changes, if any, need to be made and will bring forward such changes through a formal review of the LDS.
